Rating Action: Moody's upgrades Fox Point, WI's GO to Aaa and assigns Aaa to GO Notes; outlook stable

26 Jun 2019

New York, June 26, 2019 -- Moody's Investors Service upgrades the Village of Fox Point, WI's general obligation unlimited tax (GOULT) rating to Aaa from Aa1. Concurrently, Moody's assigns a Aaa rating to the Village of Fox Point, WI's \$1.8 million General Obligation Promissory Notes, Series 2019. Post-issuance, the village will have \$12.4 million in GOULT debt outstanding. A stable outlook was assigned to all ratings.

RATINGS RATIONALE

The upgrade to Aaa from Aa1 reflects the village's continued growth in reserves and liquidity. The village also benefits from a very wealthy tax base near the City of Milwaukee (A1 stable) that has seen valuation growth the last five years. The village has a moderate debt burden but positively has rapid principal amortization. Additionally, the village has low pension liabilities.

RATING OUTLOOK

The stable outlook reflects our view that the village will maintain strong reserves paired with a wealthy tax base and low pension liabilities.

LEGAL SECURITY

The notes are secured by the village's GOULT pledge which benefits from a dedicated property tax levy, unlimited as to rate or amount

USE OF PROCEEDS

The notes will finance various street, storm water, and other capital projects for the village.

PROFILE

The Village of Fox Point is located just north of Milwaukee along the Lake Michigan shoreline. The village spans an area of approximately three square miles and serves a 2018 estimated population of 6,652 residents.

METHODOLOGY
