Re: **Administrative Report for the Week Ending September 4, 2020**

ADMINISTRATION

1. Staff participated in North Shore Health Department EOC call.
2. Fall General & Presidential Election Fox Point ballots were approved by the Clerk's Office and proofs delivered to Milwaukee County Election Commission printer; ballots should arrive in the Clerk's office by September 17, 2020. If your ballot is not received by October 1, 2020, please call the clerk's office.
3. Village Board agenda and packet were posted to the Village website, printed and delivered by staff for the Tuesday, September 8, 2020 meeting. REMINDER: The Village Board meeting will be entirely virtual. Village Board agenda has virtual instructions.
4. Plan Commission is cancelled for September.
5. Wisconsin State Election Commission sent letters to voters as of June 1, 2020; please check myvote.wi.gov to ensure your request is on file by clicking on My Voter Information.

DEPARTMENT OF PUBLIC WORKS

1. The storm grates were installed and road repaved in the 7100 block of Beach Drive.
2. Landscape restoration activities are continuing along Barnett, View and Acacia. Staff is working to obtain quotes for the plantings around the basins on the east end of Acacia.
3. Painting of the Village Hall trim is completed.
4. DPW staff continued with tree trimming and pruning, patching potholes, yard waste collections, and prepping for crack filling activities (to begin next week).
5. DPW and Water Utility staff replaced a hydrant on Longacre that had been out of service. The old hydrant is scheduled to be removed in the next week or so.
6. Water Utility staff flushed the hydrant on the far south end of Beach Drive in response to a dirty water complaint. The complaint is because the pressure reducing valve (PRV) on the south end does not operate properly. Once replaced, the complaints should disappear.
7. Staff worked with our consultant on obtaining budget numbers for next year's proposed projects.
8. Staff worked with FEMA on the disaster declaration materials. During a conference call on Thursday, staff learned that FEMA has approved the pre-disaster placement of temporary protective structures for the south shoreline and that we are waiting on Wisconsin Emergency Management to approve the expenditures. FEMA will provide 75% of the costs

and WEM will provide 12.5%. I have requested that they also consider funding the pre-disaster costs for the north shoreline.

9. Training continues for the two new DPW employees who started last week. Staff also met with employees who celebrated their one- or two-year anniversaries.

POLICE DEPARTMENT

1. Fox Point provided assistance to Kenosha Police Department through the mutual aid agreement for one officer to assist with the visit of the President of the United States. The officer was assigned to this detail as a member of the combined North Shore crowd control team.
2. Fox Point police officers responded to a report of shots fired in the area of Doctor's Park. Upon their arrival, they found a subject with a self-inflicted gunshot wound which resulted in the persons death. The incident is being investigated by the Milwaukee County Sheriff's Office and there is not any threat to the safety of the community.
3. Officers continue to respond to reports of theft or damage to political signs.
4. Officers responded to a motor vehicle crash which resulted in the driver of the striking vehicle to leave the scene. Officers were able to identify the owner / operator of the striking vehicle and multiple citations were issued related to the crash. A hit & run crash report was submitted to the state DOT.
5. Officers responded to a report of an entry to vehicle after the car was left unlocked overnight.
6. Officers responded to check on a possible stolen car that was found in Milwaukee under suspicious circumstances. The officer was able to locate an owner for the vehicle and determine that it had been stolen the previous week but was not reported. The officer had the vehicle towed until it was recovered by a responsible party.
7. Officers responded to a report of disorderly conduct when an employee became argumentative at work when they were being terminated. The officers mediated the situation and the employee left the area.
