

**NOTICE TO ELECTORS
FEBRUARY 21, 2023 SPRING PRIMARY ELECTION
BALLOT BOX REMOVAL / RETURN OF ABSENTEE BALLOTS**

VILLAGE HALL DROP BOX TO BE TEMPORARILY REMOVED

Drop boxes used to collect absentee ballots have been prohibited due to a recent court ruling. As a result, the Village of Fox Point will be removing our drop box prior to the mailing of absentee ballots (estimated date of Tuesday, January 31, 2023). The drop box will be returned and secured following the February 21, 2023 Spring Primary Election.

RETURN OF ABSENTEE BALLOTS

Absentee ballots may be returned one of two ways:

1. Ballots may be delivered in person to the clerk at the clerk's office, as follows:

Thursdays, through February 16, 2023	8:00 a.m. - 4:00 p.m.
Fridays, through February 17, 2023	8:00 a.m. – 12:00 p.m.
ABSENTEE BALLOT HAND-DELIVERED IN PERSON TO THE CLERK IN THE CLERK'S OFFICE EXTENDED DATES/TIMES	
Thursday, February 16, 2023	8:00 a.m. – 4:00 p.m. Extended hours 12:00 p.m. – 5:00 p.m.
Friday, February 17, 2023	8:00 a.m. - 12:00 p.m. Extended hours 12:00 p.m. – 5:00 p.m.
Tuesday, February 21, 2023 – Election Day	8:00 a.m. – 4:00 p.m. Extended hours until 6:00 p.m.

OR

2. Absentee Ballots may be mailed to the clerk's office at Village Hall (7200 N Santa Monica Blvd) as soon as the ballots have been voted.

Absentee ballots are **NOT PERMITTED** to be returned to poll locations on election day.

- One exception is a personal agent returning an absentee ballot for a hospitalized elector at his/her designated poll location on the date of the election [**Wis. Stat. § 6.86(3)(c)**].
- Jurors' ballots, delivered as pursuant to the Wis. Stats.

NOTE: Residents **will not** have access to the dropbox for Water Utility bills during this time period. Current bills were due by December 20, 2022 and may be paid online or paid in-person at Village Hall during regular business hours (Monday-Thursday 8am-4:00pm, Friday 8am-Noon).
